RBI's Second Bi-Monthly Monetary Policy, 2019-20 dated June 6, 2019, has announced RBI's intention to issue Draft Guidelines for 'on tap' Licensing of Small Finance Banks by the end of August 2019

#### **Background**

The Reserve Bank of India (RBI) has issued Guidelines for 'on tap' Licensing of Universal Banks in the Private Sector, dated August 1, 2016 for granting licenses for universal banks on a continuous basis.

The 'on-tap' facility allows the RBI to accept applications and grant licence for banks throughout the year. The policy allows aspirants to apply for universal bank licence any time, subject to fulfilment of set conditions.
