Various schemes for the development, protection and welfare of children

Integrated Child Development Services (ICDS)

- Anganwadi Services, under umbrella Integrated Child Development Services (ICDS) Scheme
- Centrally Sponsored Scheme which provides a package of six services including Supplementary Nutrition (SNP) to children in the age group of 0-6 years.
- The scheme is implemented through a network of approx. 14 lakh Anganwadi Centres (AWCs) across the country.

Mid-Day Meal Scheme (MDMS)

- Centrally-Sponsored Scheme which covers all school children studying in Classes I-VIII of Government, Government-Aided Schools, Special Training Centres etc. supported under Samagra Shiksha programme.
- Objectives of the Mid-Day Meal Scheme
 - Improving the nutritional status of children in Classes I-VIII.
 - Encouraging poor children to attend school more regularly and help them concentrate on classroom activities.
 - Providing nutritional support to children of elementary stage in drought-affected areas during

Environment Education, Awareness and Training (EEAT) scheme

- Aims: To promote environmental awareness and mobilize student's participation for environment conservation.
- Objectives of the scheme are achieved through three programmes
 - National Green Corps (NGC) "Ecoclub" Programme
 - National Nature Camping Programme (NNCP)
 - Capacity Building Activities (CBA).

National Green Corps (NGC)

- About 1.6 lakh schools and colleges have been identified as Eco-clubs and nearly forty lakh students are participating in awareness programmes on various environmental issues like pollution, waste management, etc.
- The activities include celebration of important environmental days, organizing plantation drives, cleanliness drives.
- Convergence with POSHAN Abhiyaan, instructions have been given to Eco-clubs to promote herbal/ nutri-gardens, kitchen garden, plantation of medicinal plants, etc. within the school/ college campuses and neighbourhoods.

Prohibition of Child Marriage Act, 2006

- Objective: To prohibit child marriages rather than only restraining them.
- The Act prohibits the solemnization of child marriages where a person who, if a female has not completed 18 years of age and if a male has not completed 21 years of age.
- According to the Act, child marriage is a cognizable and non-bailable offence.

Child Protection Services (CPS) Scheme

- CPS Scheme is Centrally Sponsored Scheme.
- Objective: To create a safe and secure environment for overall development of children who are in need of care and protection.
- CPS Scheme includes orphan/abandoned/surrendered children.
- Under the scheme, institutional care is provided through Child Care Institutes (CCIs) as a rehabilitative measure.
- The programmes and activities include, inter-alia, ageappropriate education, access to vocational training, recreation, health care, counselling etc.
- Under the non-institutional care component, support is extended for adoption, foster care and sponsorship.
